

“OFFICIAL ON-AIR CONTEST RULES”

1. How to Enter:

The WLDE On-Air Contests air between January 01, 2023, and end on December 31, 2024.

No purchase necessary.

To participate, listen each weekday between 6:00am and 7:00pm. When WLDE plays a contest be the correct caller at (260)-426-5343 for a chance to win. There will be no contests on corporate or national holidays.

WLDE will award the prize after the correct caller meets all eligibility restrictions.

If the correct caller does not meet eligibility restrictions, the next caller will be taken until the prize is awarded. If no prize is awarded, it will remain the property of WLDE.

Portions of sound effects that are featured in commercials, promos, sound bytes and news clips not considered a part of the actual on-air contest are not eligible.

2. Eligibility Restrictions:

WLDE contest are open to legal residents 18 years of age and older and who reside in the WLDE, Classic Hits 101.7 listening area including the following counties: Allen, Adams, Dekalb, Whitley, Wells, Noble, Steuben, Huntington in Indiana, and Defiance, Van Wert and Paulding counties in Ohio. Employees and family members of Sarkes Tarzian, Inc., participating retailers/sponsors, and employees of other radio stations in the Fort Wayne Metro area are not eligible to participate and win. Family members are defined as parents, children, spouses, in-laws, those in spouse-like relationships, and siblings (including those in step and half relations when living in the same household.) The winners may be required to sign an Affidavit of Eligibility and a Receipt for Prize and Award upon acceptance of the prize.
