### General

WAJI/WLDE/WGBJ takes user privacy seriously and is committed to protecting it as described in this Privacy Policy. Below we explain how WAJI/WLDE/WGBJ collects, handles, and uses information when you use the <a href="https://www.majic951.com/">https://www.majic951.com/</a>; <a href="https://www.thetwentyfm.com/">https://www.thetwentyfm.com/</a> websites; or the mobile applications owned by WAJI/WLDE/WGBJ, including, but not limited to, the majic95.1 App; the classichits101.7 App and the Alt99.5 and 102.3 Apps, and any widgets, tools, features, content (including videos and images), services and options that we may offer in any format (collectively, the "Website"). WAJI/WLDE/WGBJ are licensees of Sarkes Tarzian, Inc. All references to WAJI/WLDE/WGBJ refer to both Sarkes Tarzian, Inc. and WAJI/WLDE/WGBJ. Please read this Privacy Policy carefully.

Unless stated otherwise, this policy applies to information collected via the Website or through email and other electronic messages between you and WAJI/WLDE/WGBJ. This policy does not apply to information collected by us offline or through any other means, including on any other website operated by WAJI/WLDE/WGBJ or any third party, or to information collected by third parties, including through any application or content that may link to or be accessible from the Website.

If you do not agree with our policies and practices, your choice is not to visit the Website. By

accessing or using this Website, you agree to this Privacy Policy and our Terms of Use (the "Terms"). All capitalized terms in this Privacy Policy that are not otherwise defined have the meanings given to them in the Terms.

By submitting your personal data to us through the Website you consent to our collection, use, processing, sharing, storage, security, retention, and access as described in this Privacy Policy.

# **Eligible Users**

By using this Website, you represent and warrant that you meet all of the following eligibility requirements. If you do not meet all of these requirements, you must not access or use the Website.

No Use of Site by Children Under 13. The Website, and the services offered through the Website, are not directed at or intended for use by children under 13 years old. If you are under the age of 13 you should not be visiting the Website. We do not knowingly collect or retain personal information from children under 13. If you are under the age of 13 and are visiting or otherwise using the Website, please exit the Website immediately and do not disclose or provide any personally identifiable information to us.

Users Outside the United States. ### Information We Collect and How We Collect It

While legal definitions of personal information can vary, we consider "personal information" to be any information that identifies you as an individual or is directly relatable to an identifiable individual. The types of personal information we collect include, the following:

- Individual contact and demographic information, such as first and last name, postal address, username and password, email address, telephone number, and date of birth.
- Payment card information where applicable.
- Photos, videos, or other recordings you choose to post to the Website or email to us as part of entering promotions or sweepstakes.

- Website usage data and information about your internet connection, the equipment you use to access our Website, IP address, geolocation, and other related information that helps us create a better experience for users of the Website.
- Any other information you voluntarily provide when you contact us through the Website that may identify you or allow online or offline contact with you.

### We collect this information:

Directly from you when you provide it to us, for example, by submitting an inquiry or comment to us online, signing up to receive emails from us, or sending messages to us.

Automatically when you visit or use our Website and our applications as described below.

When you use the Website, we or our third-party service providers automatically collect information from you through tracking and similar technologies that tells us which pages were visited and by how many users, the order in which pages were visited, and which hyperlinks were "clicked." Not all of this information is personal information as we define it above. The technologies we use for automatic data collection may include:

Cookies. A cookie is a piece of data that's either stored in your computer's memory temporarily and automatically deleted when you close your browser (a "session" cookie) or placed on your hard drive (a "persistent" cookie) by a web server. A persistent cookie is not deleted when the browser is closed. Cookies allow us to make your interaction with the Website faster and more personal, for example by remembering your preferences the next time you return to the Website. Cookies also allow us to monitor how you and other users use the Website. This information can be used to improve the site or detect and prevent site misuse.

Web beacons. Web beacons, which are also known as clear GIFs, bugs or pixel tags, are often used in combination with cookies. They are small electronic file images (often transparent) that are embedded as part of the Website for the purpose of monitoring the behavior of persons who interact with the Website, for example by counting the number of persons who have visited a page or the popularity of certain content.

You are able to control how and whether cookies will be accepted by your web browser or device. For more information on how to do so, please refer to your browser help menu to learn how to disable cookies. Some features of the Website may not function properly with cookies disabled.

### **How We Use the Information Collected**

We use information collected through the Website as follows.

- To present the Website and its contents to you.
- To deliver localized weather and news alerts and other relevant information to you.
- To act on and respond to your requests and inquiries.
- For marketing and advertising purposes. These uses include but are not limited to retargeting advertising, or serving you ads once you have left the Website and analyzing the effectiveness of our promotions.
- To analyze Website usage and improve our Website functionality.
- To diagnose problems with our server, administer the Website, identify the most popular areas or features of the Website, identify where our users are coming from and determine the effectiveness of our promotional activities.

- If and when we sponsor promotions or sweepstakes, or third parties sponsor promotions or sweepstakes in conjunction with us, either we or the third party will post relevant privacy information in the official rules and/or registration area for the promotion or sweepstakes. That privacy information, to the extent it conflicts with this Privacy Policy, will govern that particular promotion or sweepstakes.

### **How We Share Your Information**

WAJI/WLDE/WGBJ shares your personal information in the following circumstances:

When you submit a comment or reaction to a post, if this feature is enabled, this content will be publicly displayed via the Website.

We may disclose certain automatically collected information to advertisers to inform them of the number of people who have seen and/or clicked through their advertisements or promotions. This is generally not personal information as we define it.

We may share personal information with third parties that perform services on our behalf, for example, our technical and marketing service providers. We may also share certain information with third-party providers of cloud, web and/or server hosting services. Certain third-party service providers utilized by us may collect personal information from you as authorized by us. Our service providers may provide data collected by them through the Website to us, such as reports of email addresses they collect, store and/or process for us, which we may use for our business purposes. We are not responsible for the privacy practices of these service providers or of other websites. By using our Website, you consent to the processing and handling of your personal information by our service providers in the manner and for the purposes described here and in their respective privacy policies. We will not authorize these third parties to use your personal information except as necessary to provide services to us or for purposes authorized by us.

Additionally, we may disclose your personal information (1) to comply with a law, regulation or other governmental request, for example, to comply with subpoenas, court orders, legal process or requests by law enforcement or governmental entities; (2) to investigate or defend against third-party claims against us; (3) to detect, prevent or investigate fraud or other illegal activity or to enforce this policy; (4) to repair or resolve technical issues in the operation of the Website; (5) if required by law, to respond to a request by you to disclose the information, including a request to allow access to your personal information by third parties designated by you; (6) with your knowledge and consent; and (7) to address emergencies or acts of God. We may also share your personal information as an asset of the business in the event of a sale, merger or other business combination or transfer involving us or affiliated entities.

### **How Do We Protect Your Information?**

WAJI/WLDE/WGBJ takes the security of your personal information seriously. We implement commercially reasonable technical, physical, and administrative security measures to protect against the loss, misuse and unauthorized access, disclosure, alteration and destruction of personal information collected through the Website. These security measures include Secure Socket Layer (SSL) technology data transmission.

Unfortunately, the transmission of information via the Internet is not completely secure. We cannot and do not guarantee that your personal information will never be accessed by an unauthorized party or otherwise breached during transmission through the Internet. Additionally, any contact

with us by email or by way of our Website might not be secure. Any transmission of personal information is at your own risk. We are not responsible for circumvention of any privacy settings or security measures contained on the Website.

In the event that we believe any information that you provided to us has been exposed to unauthorized third parties, we will notify you as required by law or upon our own choice.
