

## **“CONCERT IN CLEVELAND” OFFICIAL RULES**

### **1. How to Enter:**

The WLDE “Concert in Cleveland” Contest will begin Wednesday, May 01, 2024, at 7:00 am, and end on May 20, 2024, at approximately 8:50 am.

No purchase necessary.

To participate, listen each weekday between 7:00am and 7:00pm during the contest dates. When WLDE plays a song from Billy Joel and a song from Rod Stewart back-to-back, the 10<sup>th</sup> caller at (260)-426-5343 will be a finalist for the Grand Prize.

WLDE will designate the 10<sup>th</sup> caller as a finalist upon meeting all eligibility restrictions.

If the 10<sup>th</sup> caller does not meet eligibility restrictions, the next caller will be taken.

Once the back-to-back songs have played during the designated time, listeners to WLDE have 10 minutes to be the 10<sup>th</sup> caller, otherwise no finalist will be taken that episode of the contest.

Portions of Billy Joel and Rod Stewart songs that are featured in commercials, promos, sound bytes and news clips are not considered the “cue to call” and are not eligible in the contest.

WLDE will reveal the contest hours the Billy Joel & Rod Stewart songs will be played back-to-back each weekday at 7:20 am. A participant can also get the hours each weekday starting 7:30 am by texting the letters VIP to (260)-426-5343. A participant must have a mobile device with texting service to receive texts by Studiotexter and be provided with the contest hours each weekday during the contest.

### **2. Eligibility Restrictions:**

The Concert in Cleveland” Contest is open to legal residents 18 years of age and older and who reside in the WLDE, Classic Hits 101.7 listening area including the following counties: Allen, Adams, Dekalb, Huntington, Kosciusko, LaGrange, Noble, Steuben, Whitley, and Wells in Indiana. Defiance, Van Wert and Paulding counties in Ohio. Employees and family members of Sarkes Tarzian, Inc., participating retailers/sponsors, and employees of other radio stations in the Fort Wayne Metro area are not eligible to participate and win. Family members are defined as parents, children, spouses, in-laws, those in spouse-like relationships, and siblings (including those in step and half relations when living in the same household.) Anyone who has worked for or interned with Sarkes Tarzian, Inc. is not eligible to participate or win.

### **3. Selection of Winners:**

One Grand Prize Winner will be determined by random selection from all eligible finalists in the contest, and will take place on May 20, 2024, at 8:50a.

The odds of being a finalist depend on the number of calls received each time an episode of the contest is played.

There will be a total of 26 finalists in the contest. The odds of a finalist winning the Grand Prize are 1 in 26.

### **4. Prizes:**

2 tickets to the Billy Joel & Rod Stewart concert at Cleveland Browns Stadium, on Friday, September 13<sup>th</sup>, along with overnight accommodation for 2 at the Residence Inn by Marriott Cleveland Downtown. The contest will qualify 2 finalists each weekday during the contest dates.

Prize Value:

2 tickets to Billy Joel & Rod Stewart with taxes and fees from Ticketmaster is \$573.40. Overnight accommodation including taxes and fees at Residence Inn by Marriott Cleveland Downtown: \$656.92.

Total Grand Prize value: \$1,230.32.

Prizes are non-transferable by WLDE.

The Grand Prize must be claimed by the winner and no one else, unless otherwise determined by station management. Both the concert tickets and hotel reservation will be digitally transferred to the winner. The winner must have a working email address to claim the Grand Prize. The email address to receive the prize transfer must be the authorized account holder of the email address submitted to WLDE. The authorized account holder is the natural person who is assigned to the email address by an Internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address.

### **5. Conditions:**

Payment of all federal, state and local taxes is the sole responsibility of the winner. Winners will be reported to the IRS-on-IRS Form 1099 or the equivalent should the total amount of winner for a contest exceed \$600 during a contest year, which goes back 12 months from their most recent date of winning.

By participating in the contest, the winner agrees to allow their name, voice, and/or likeness to be used in any advertising or broadcasting material relating to this contest for a period of one year without any financial or other compensation.

The winners may be required to sign an Affidavit of Eligibility and a Receipt for Prize and Award upon acceptance of the prize.

Pursuant to the above-mentioned paperwork, the winners will agree to hold WLDE, Sarkes Tarzian, Inc., and the respective officers, shareholders, directors, employees, agents and representatives of each of them harmless from and against any and all claims or liability arising directly or indirectly from the prize or participation in the Concert to Cleveland Contest.

All winners must show proper identification and sign a prize receipt and publicity release prior to the acceptance of the prize.

A contestant may qualify once during the contest. No more than one finalist per household.

WLDE, in its sole discretion, reserves the right to disqualify any person who is in violation of the rules.

Anyone who has won \$600 or more in the last 6 months is also ineligible.

The station further reserves the right to cancel, terminate or modify the Concert to Cleveland Contest if it is not capable of completion as planned, including tampering, unauthorized intervention, or technical failures of any sort.

If a contest episode is missed for any reason, it will be made good later that contest day. If it can't be made good on that contest day, it will be made good at the end of the contest, even if the contest dates need to be extended to complete the contest.

These rules are subject to the interpretation of WLDE. Any aspect of these rules, including the substitution of a prize or prizes of equivalent or greater value, can be changed at the discretion of WLDE, and such changes will become effective upon on-air or other appropriate announcements.

This contest is void where prohibited.

WLDE reserves the right to terminate the Concert in Cleveland Contest at any time, without notice.

WLDE is not responsible for the concert being cancelled or postponed.

WLDE is not responsible for the rescheduling of hotel reservations if the concert is rescheduled to a later date.

Failure to comply with the rules may result in disqualification, at the sole discretion of WLDE.

WLDE is not responsible for typographical or other errors in the printing, the offering, or the administration of the guarantee or in the announcements of any prize.

WLDE is not responsible for telephone service outages, delays, busy signals, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call.

As a consequence of delays in the online streaming of the WLDE signal compared to over-the-air broadcasts, online listeners may be at a disadvantage in attempting to participate in the Concert in Cleveland Contest, entrants are encouraged to listen to the station on-air. WLDE is not responsible for online streaming delays.
